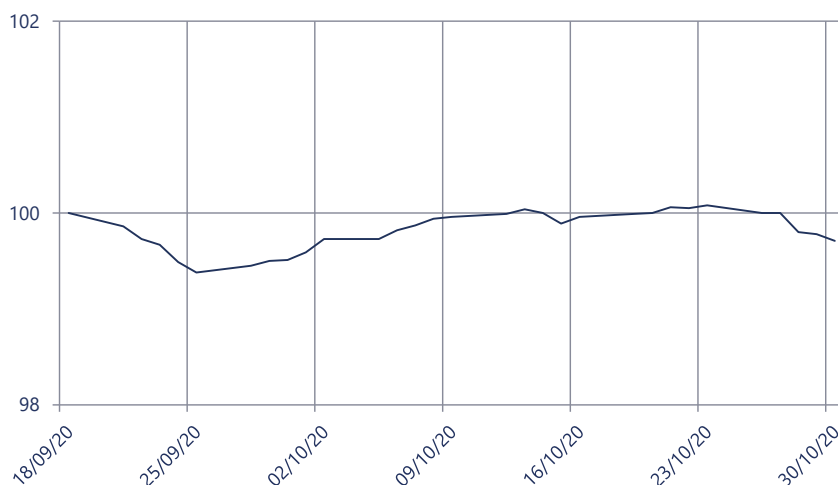

FUND OVERVIEW

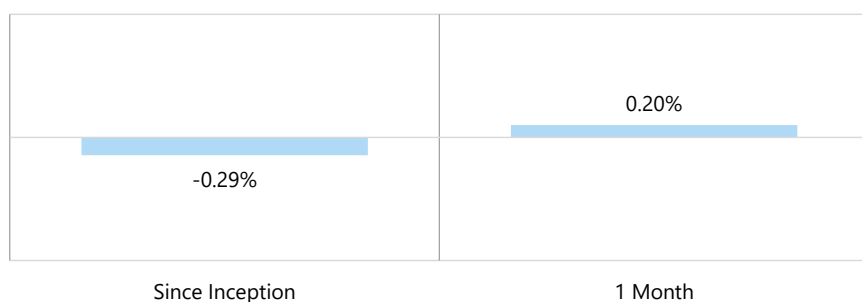
The GAMA Global Short-Dated Opportunities Fund is a short-maturity bond fund for investors seeking higher returns than money market funds. The investment objective of the fund is to generate returns of 2% per annum over cash with a volatility in the 2%-3% range. The fund is suitable for investors who have an investment horizon of one year and more.

The fund's main source of return is expected to be its exposure to credit. Interest rate exposure is kept low and currency exposures are fully hedged. The fund managers follow a rigorous investment process which combines in-depth fundamental analysis and robust quantitative models with the aim of exploiting the opportunities that exist at the short end of the global corporate bond universe.

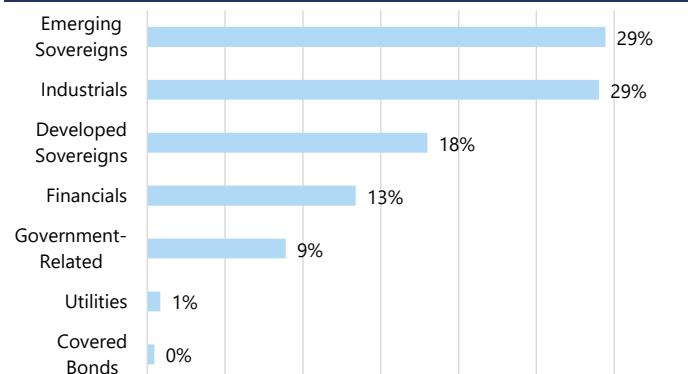

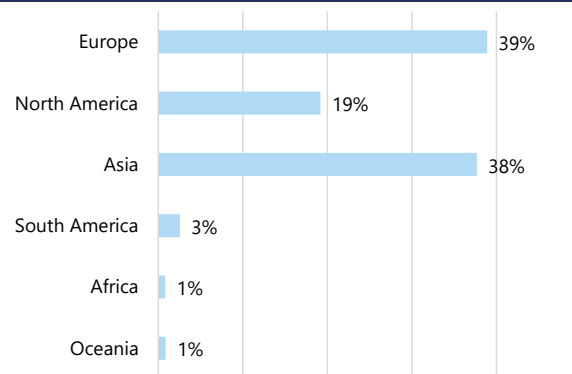

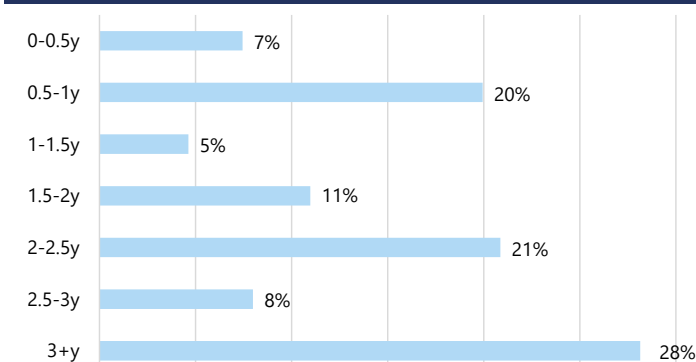
BREAKDOWN BY SECTOR



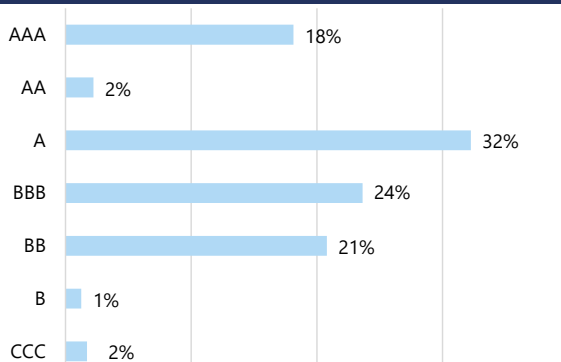
BREAKDOWN BY REGION



BREAKDOWN BY MATURITY



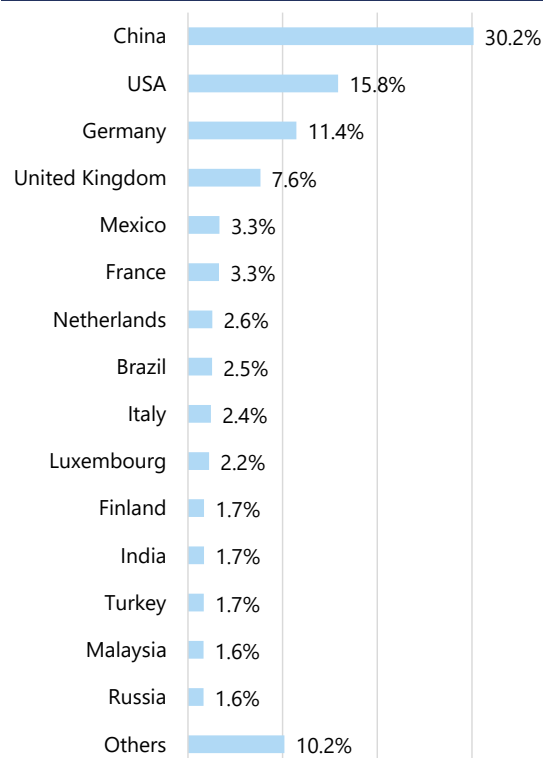
